# DATA PROTECTION

In accordance with the Data Protection Act 2018, the Channel Islands Specialists' Society needs your consent to collect and retain your contact details for Society business. You are expected to inform the Society of any changes of your contact information.

The Society does not release any of your data to other members or to external bodies without your permission. We do not release your data (for example) to stamp dealers. Data will be shared with the Society's Officers in accordance with the needs of their office.

As you are applying for membership, you are required to complete the following data handling agreement:

## Data Handling Agreement

**Purpose** – The Channel Islands Specialists' Society will use and hold the supplied data for the purpose of organizing the Society, circulating the exchange packet to members, and to provide services to the membership, including distribution of the Society's quarterly Journal and auction catalogues.

**Period of holding the data** – The Channel Islands Specialists' Society will hold contact and financial data for a minimum of 7 years from the date of application or most recent membership renewal.

**Cancellation** – you can cancel this agreement at any time and your details will be removed. Please contact the Membership Secretary of the Channel Islands Specialists' Society. Cancelling this agreement will mean that you are cancelling your membership of the Society.

**Security of data** – The Channel Islands Specialists' Society will handle the data in a secure form and will not distribute it to third parties other than for the purpose outlined above. The Channel Islands Specialists' Society uses a third party printing and mailing firm for the distribution of the printed Journals, for which a data sharing agreement is used.
